5. NOISE COMPLAINTS

Manchester City Council and Greater Manchester Police take all noise complaints seriously and will endeayour to respond to any reports. We will assess each incident and ensure a proportionate response. In order to report a noise complaint during the Carnival weekend you can contact Greater Manchester Police on 101 who will be able to provide you with updates and advice.

This leaflet therefore is to make you aware of the agreed activities that are taking place, the times, the routes, and the expectations regarding levels of noise.

1. THE CARNIVAL TAKES PLACE AT ALEXANDRA PARK, MOSS SIDE

Saturday 12th August 2017 ~ 12noon till 8pm Sunday 13th August 2017 ~ 1pm till 8pm

2. J'OUVERT PARADE WILL TAKE PLACE ON

Saturday 12th August at 9am

This event is recognition of the struggles that Caribbean people suffered during their fight for independence and celebrates the music of that time. The parade will consist of two parade vehicles and a number of people following behind. This will start at 9am Grierson Street Car Park and finish at the end of Quinney Crescent by around 10am.

There will be some disruption to road users and loud music during this time.

The route for this procession is outlined in the map.

3. THE CARNIVAL PARADE WILL TAKE PLACE ON

Saturday 12th August at 12.30pm

The parade leaves Alexandra Park at 12.30pm and is expected to return at 3.30pm. There will be some disruption to road users and loud music during this time. The route the parade will take is as outlined in the map.

4. NOISE ISSUES

Over the last couple of years there has been an increase in the number of street parties occurring following the Carnival activities. These events have caused distress for a number of residents due to the anti-social behaviour displayed by certain people, and the loud music being played into the early hours of the morning.

These parties are not authorised by Manchester City Council or Greater Manchester Police, and as such a proportionate joint response will be in place throughout the weekend to minimise the impact on local community members. If necessary and where appropriate legal action will take place if offences are being committed. These parties are not considered safe and as a result we advise strongly that residents do not participate in such events.

The Carnival Committee encourage people to attend events at organised licenced premises. The Carnival, Parade and J'ouvert events are all subject to noise monitoring to ensure they meet legal requirements.
